10. Maduro has caused the south and central American human trafficking crisis as Venezuela has now 7.1 million refugees, as per united nations calculations. This is the United States current immigrations crisis at our southern borders, and Title 42 applies to the Venezuelans. 11. Maduro's actions have emboldened other countries to operate more against the United States. Examples are Cuba emboldened, Nicaragua has arrested 222 Catholics including a Bishop and sentenced them to 26 years in jail. The linkage is directly related to Maduro's actions.

Petitioner's plea:

Petitioner prays the court hears the following matters. If the information was available prior to 911 we could have averted the tragedy that befell the United States 22 years ago. As of this date the facts are the following:

1. Over 100 terrorists have been caught at the US border (ISIS, Hezbollah, and more) 50 U.S. Code § 21 - Restraint, regulation, and removal – Invasion, 18 U.S. Code § 1505. Obstruction of proceedings before departments, agencies, and committees
2. China has increased spying activity and secret police action on US soil.
3. Maduro has made open threats against the United States and conspired with Russia, China, Iran.
4. Cartel's have freedom of movement causing increase in drugs and human trafficking.

The ability to prevent any further harm to the United States and stop any mass casualty event is the duty of the executive branch.


Petitioner's remedy:
